




#### Daily Confirmed Cases on Navajo Nation in All















#### Navajo Safe Water: Protecting You and Your Family's Health

#### SAFE CHAPTER WATER POINT USE & RESTRICTIONS

- Practice physical distancing by getting water when fewer people are around. Do not gather in groups.
- Remain in your vehicle until your turn to fill your water container.
  Cover your mouth and nose with a cloth face cover if you need to get out of your vehicle.
- . Stay at least 6 feet (about 2 arm lengths) from other people.
- Use disinfectant wipes or spray to clean commonly touched areas such as
  the watering point handle, spigot, hose, and card reader entry points.
- Hold the hose above the water container while filling. Do NOT put hose in the container.
- Disinfect your hands before and after using the watering point.
  (1) with with soap and water for at least 20 seconds or (2) use a hand sanitteer that contains at least 60% alcohol.

Water for in-home use only NOT for livestock use NOT for agricultural use
