



Informal settlements are home to 1 billion people

Floods are a growing hazard

Global population exposed to floods is **ten times higher** than previously expected and increasing (Tellman et al., 2021)

Informal settlements are susceptible to flooding due to *lack of infrastructure and services* to protect against flooding (Satterthwaite et al., 2020)


Short and long-term concerns over habitability with climate crisis

Satellite imagery can aid in tracking flood impacts

Tellman Lab is working to build models to detect flooding across complex urban geographies

Deep learning models to combine imagery from multiple satellites

Aim: global 3-day, 3-meter maps of flood probability




Translating flood risk into anticipatory climate adaptation

Anticipatory action – proactively address emerging risk

- Enforced flood protection
- Planned relocation + managed retreat

Research agendas for anticipatory planning

- Effective and relevant data for decision making
- Monitor repeat flood events
- Identify exposed populations with insecure housing
